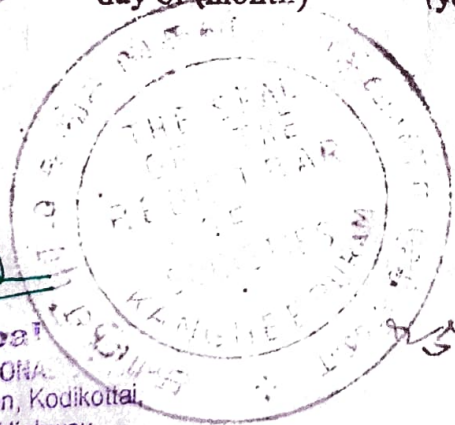

c. Create employment opportunities among the villagers through suitable projects.

d. Promote saving cum loans schemes to enhance the purchasing capacity of the underprivileged.

e. Organise benefit scheme and cooperative undertaking

14. President:


1. The President shall be Executive head of the organisation
2. His advice shall be taken in all matters pertaining to the administration of the society
3. She shall preside over all meetings conduct the meetings in a democratic manner.

15. Vice-President:

Vice President shall act on behalf of the president whenever the latter so instructs or is absent from station or is unable to attend any meeting of the General Body or Executive committee, and regulate the proceedings thereof. When he acts on behalf of the president he shall have the liberty to exercise one original vote and in case of equality of votes, a casting vote.

16. Secretary & Treasurer:

The Secretary & Treasurer shall manage the day to day affairs of the society and meet the expenses in connection therewith subject to superintendance, guidance and control of the Executive committee. He shall also convene meeting of Executive committee and also of the General Body and keep the minutes thereof.


17. Executive Committee Meeting:

A meeting of the Executive committee members will be convened once in three months at a specified place and date after prior notice of 10 days. Quorum of meeting shall be 1/3 of the total membership of 4 executives whatever is less. All resolutions of the executive committee shall be carried out by a majority of votes. The president or in his absence the Vice-President or in the absence of both any member appointed by the members there present shall preside over the meeting and have a second or casting vote in case of equality of votes. A statement of accounts and a copy of the report shall be placed before the Executive Secretary & Treasurer.

18. Power of Executive Committee:

The Executive Committee shall have the entire control management of the business and affairs of the society and shall have all such powers of the society and to all such things to carry out the general objects of the society, as are, by the Tamil Nadu Societies Registration Act, 1975 not required to be exercised or done by the society in General Meeting.

19. The accounting year of the organisation shall be commencing from its April to March. The accounts will be closed for the year ending and new accounts will be commenced for the next accounting financial year.

20. The General Body shall appoint auditor or auditors as it deems fit. The accounts of the organisation shall be audited by a qualified auditor or auditors as per Sec.16(1) and rule 21(2) of the Societies Regn. Act.

21) Every member of the organisation can be entitled to get a copy of the rules and regulations audited of Income and Expenditure balance sheet etc on payment of one rupee per copy on written application to the Secretary.

11) No fine shall be imposed for any breach of the provision of the bye-laws by the members of officers.

22) 1. All moneys of the organisation shall be deposited to any nationalised Bank as decided by the Executive committee of the organisation and will open in the name of the organisation

2. All deposits and withdrawals shall be made only by President

3. The Treasurer & Secretary can retain a sum of Rs.50/- (Not exceeding) for meeting of the urgent and unforeseen expenses, Exceeding that the amount shall be remitted to the bank.

23) 1. Normally the Annual General Meeting shall be held in a year within a period of three months after the expiry of the financial year, on or before the month of June such meeting shall be transact the following business.



b) The notice specifying the day, hour, place and any amendments in objects or by-laws, shall be intimated along with the copy of the Notice. The Notice in the General Body Meeting shall, to set tapal to the members through postal, or local in advance of 21 days clear. The organisation for the notice shall be affixed in the notice board of organisation.

25) a) The Executive committee can convene extra ordinary General Meeting at any time with prior notices for 21 days for such meeting.

b) The Extra ordinary General Body Meeting shall be called when 1/3rd majority of members of the organisation made requisition to convene such meeting, the executive committee shall call such meetings, with in one month from the date of receipt of that requisition.

c) If the extra ordinary General Body Meeting is not called in accordance with such requisition the requisitionists shall have power to call such meeting themselves .

26) If the quorum not formed for General body meeting, the General body meeting shall be postponed to next month, and in respect of the extra ordinary meeting, the above meeting shall be postponed to next month. The next meeting shall not be postponed again, the meeting shall be conducted with the members present. Every member may exercise his or her vote and in the event of its equality the President shall have the casting vote. Quorum of the occasion 1/3rd of the majority of the members present in person who are entitled to vote.

27) Special resolution shall be passed at a general body not less than 3/4 th of the majority of the members present in person, who are entitled to vote for the following purposes of.







EXTRACT OF THE SPECIAL RESOLUTION PASSED IN THE EXTRA- ORDINARY GENERAL BODY MEETING OF THE SOCIETY HELD ON 18TH MARCH 2016. AT THE SOCIETY OF DAUGHTERS OF MARY IMMACULATE AND COLLABORATORS, AMALA BHAVAN, RUDRA ROAD, ST. THOMAS MOUNT, CHENNAI - 600 016.

The President brought to the notice of the members that there is a requirement from the bankers for the purpose of obtaining loan for our educational institutions The appropriate authorities have advise us to amend the following clause contained in the Memorandum of Association of Our Society to create a charge on the immovable properties belonging to the Society by mortgaging them in favour of third parties, more particularly, Societies or Trusts coming under the DMI group to enable them to raise credit facilities. There are opinions from different advocates that there is no bar on Societies for mortgaging or giving guarantees in favour of third parties.

As the existing bye laws of the Society of Daughters of Mary Immaculate and Collaborators do not specifically provide for such provision of creating mortgage of immovable properties and / or extending its guarantee in favour of third parties, it is deemed essential to make an amendment to the existing bye laws. However, such creation of mortgage and / or extension of guarantee shall be restricted to within the entities only.

The President also informed members that Income Tax Department, Government of India, has given their approval to this amendment.
